- 3. The Exclusive Group Corona Kavach Insurance Policy may consist of the following *minimum features*:
  - a) Policy should cover minimum of 285 days from the date of effect.
  - b) Age for coverage in policy should be from Day 1 to 80 years to enter the policy.
  - c) There should not be any capping on the Room Rent for ICU/ICCU as well as Normal Room.
  - d) First 15 days / specific waiting periods should be waived off.
  - e) Pre and post hospitalization minimum 30 and 60 days respectively.
  - f) Claim settlement period not exceeding 15 working days after submission of claim.
  - g) Cover includes treatment for any co-morbid conditions also.
  - h) No sub limits for persons suffering with any of the Co-Morbidities
  - i) Home care treatment payable for a maximum period of 14 days per incident, provided a medical practitioner has prescribed home care treatment.
