- 2. IIMT invites sealed tenders through advertised tender enquiry for "Supply, Installation, Testing and Commissioning of Interactive Monitor (06 Nos) at IIM Tiruchirappalli"
- 3. The bidder(s) should remit a Non-Refundable Tender document fee of *Rs. 1,180/-* (inclusive of GST) through online transfer to "IIM TIRUCHIRAPPALLI" as per the bank details provided at the page one. A copy of the payment transaction receipt has to be attached with the application form, without the tender won't be consider for bidding process.
- 4. The bidder(s) should remit an Earnest Money Deposit (EMD) of **Rs. 20,000**/- (Rupees Twenty Thousand Only) through online transfer to "IIM TIRUCHIRAPPALLI" as per the bank details provided at Page one. A copy of the payment transaction receipt has to be attached with the tender application form, without which the tender won't be considered for the bidding process. The EMD of the successful bidder will be adjusted against the Security Deposit due to be paid. The EMD of the unsuccessful bidders will be released after finalization of the tender.
