GENERAL SPECIFICATION FOR ELECTRICAL WORK:

SCOPE

- 1.In general, the contractor shall supply, erect, test and commission the CT (Current Transformer) installation. The contractor shall furnish all the materials, labour, tools and equipments for the electrical work.
- 2. Testing & Calibration of over current / Earth fault/ breaker Protection auxiliary relays of analog / digital type relays in the existing RMU which was installed in our main panel. After completion of work, the test certificate should be submitted by the vendor

Terms & conditions:

- 1. The above cost should be including supply, freight Charges, loading & unloading and excluding GST.
- 2. The Bidder (s) should be registered with the Goods and Services Tax council for the purpose of Goods & Service Tax (GST). A copy of the GST registration certificate has to be submitted with the tender document. A copy of the GST Registration Certificate, PAN and Bank account details should be submitted along with the Bid. The names appearing on all these documents and the tender document should be the same or linked.
- 3. The Contractor shall be a licensed electrical contractor (A grade), possessing a valid electrical contractor's license from the state government. The supervisors of the firm should possess valid license and skilled workers should possess valid permits as per the Regulation of Indian Electricity Rules and Local Electrical Inspector's requirements.
- 4. If a fault arises in our existing electrical system during CT installation, the vendor should bear the entire responsibility.
- 5. The contractor should have HT electrical work experience of at least two years, which should be submitted.
- 6. Bidder should take into account the Corrigendum/Addendum published in the IIM Tiruchirappalli website on the tender page from time to time before submitting the bids.
- 7. **Delivery Schedule:** within **10** days from the date of receipt of the Work Order. If the agency/firm fails to supply the items within the stipulated period, the Work Order will be canceled.
