Query: Could you please provide details on the current technical architecture of the website, as well as any challenges you're facing?	Currently, we are using Drupal for the website.

Standardization Testing and Quality Certification (STQC) is a security and quality audit certification. The vendor has to coordinate with STQC to obtain both Website Security Testing/Audit and Website quality certification (CQW) which are recognitions that the website complies with the security requirements & the requirements of GIGW and the organization has adequate procedures & processes in place to provide reliable & dependable information and service through their website. IIM Trichy will also provide necessary guidance to the vendor and required documents to STQC for the same. The necessary employees like coordinator/Creative Director, photographer, videographers etc. shall visit the campus as and when needed as per the tender clauses.
8		Are there any new content requirements for the redesigned site?	The details of the new modules that are not available on the current website are given in the tender.
9		For Video on website, can we consider Embedding from a Video	Video has to be created by capturing the live campus videos by professional

		Hosting Platform (e.g., YouTube)? or Using a Direct Link (Hosted on Your Server)	videographer(s) using professional good quality cameras and the video should be developed by a professional video editor with proper planning and approval from IIM Tiruchirappalli. Any existing videos that are available on social media or websites should not be used.

We anticipate that this will primarily be an informational website, and thus, there might not be a need for functionalities demanding user login or specific user management, Please clarify? At least once in two years, the vendor should handle the version upgradation to avoid any interoperability issues with latest applications.

26		Please elaborate 3-D content?	The vendor has to make 3 D designs if they feel it would give more attraction to a particular section/page of the website.
