

3. The Exclusive Group Corona Kavach Insurance Policy will consist of the following *minimum features*:

- a) Policy should cover minimum of 285 days from the date of effect.
- b) Age for coverage in policy should be from Day 1 to 80 years to enter the policy.
- c) There should not be any capping on the Room Rent for ICU/ICCU as well as Normal Room.
- d) First 15 days / specific waiting periods should be waived off.
- e) Pre and post hospitalization expenses applicable for 15 and 30 days respectively.
- f) Claim settlement period not exceeding 15 working days after submission of claim.
- g) Cover includes treatment for any co-morbid conditions also.
- h) No sub limits for persons suffering with any of the Co-Morbidities
- i) Home care treatment payable for a maximum period of 14 days per incident, provided a medical practitioner has prescribed home care treatment. This benefit should cover doctor consultations, paramedic assistance, regular vital monitoring by nurses, investigations, pharmacy (medicines), Non-Medical (PPEs, hand wash, shoe cover, caps, gown, face mask, face shield and such similar items)
- j) This policy should cover room rent, boarding and nursing expenses; medical practitioner, consultants and specialist fees; blood, oxygen, ventilator charges; surgical appliances; medicines and drugs; costs towards diagnostics, diagnostic imaging modalities, PPEs, hand wash, shoe cover, caps, gown, face mask, face shield and such similar items.
- k) The Covid-19 hospitalization expenses incur under AYUSH (as defined in IRDAI Regulations, 2016) systems of medicine, should be covered up to the sum insured without any sub-limits.
- l) **Hospital daily cash cover**: Daily minimum allowance of Rs. 2,500/- per day. Applicable for each 24 hours of continuous Covid-19 hospitalization, payable maximum up to 15 days during the policy period.
- m) New born baby should be covered since birth (Added at the time of renewal).
- n) Day one covers for new joinee on regular basis/Institute contract and their dependents as per eligibility.
- o) Mid-term inclusion of existing employees newly acquired dependent (newly married spouse / new born baby, newly adopted child). Mid-term deletion if the Institute employees retire/resign and the balance amount, if any, on this account need to be adjusted against the new joinee.



- p) If one of the family members is found Corona positive, the policy should cover the COVID testing charges for other family members/ dependents.
 - q) Insurance cards to all the member should be provided within fifteen days from the start of the insurance cover.
 - r) No proportionate deductions.
 - s) Road ambulance expenses subject to a maximum of Rs. 2000/- per hospitalization.
4. In addition to above, the Insurance Company shall also offer other benefits such as waiver of all exclusions, provision for second opinion etc. without affecting the premium amount.
 5. Apart from above, please provide the following details: -
 - a) Day care procedures list.
 - b) Charges/Tests/ or any other items which are not covered.
 - c) List of clients (preferably from educational institutions) where such Group Corona Kavach Insurance Policy are under operation.
 6. Brief profile of Third Party Agency (TPA) & their registration details. There should be a dedicated helpline (24x7) from the Third Party Agency (TPA) of insurance company available and the contact details of the same should be furnished.
 7. Complimentary corporate buffer, if any, with details.
 8. Special services (if any), without any additional cost.
 9. Tax will be deducted as per rule in force.
 10. Any legal disputes that may arise shall be subject to the jurisdiction of Madurai Bench of Madras High Court.






