Checklist of Documents to be submitted along with duly filled Application Form

STUDENT- APPLICANT:

- Proof of Identity (Any one): PAN/Passport/Driver's License/Voter ID Card
- Proof of Residence /Address (Any One): Copy of Passport/Driving License/Aadhaar Card
- In case passport is not available, it is to be submitted in six months.
- Academic Records:
 - i) 10th Result
 - ii) 12thResult
 - iii) Graduation Result- Semester-wise (if applicable)
 - iv) CAT Score card e. Proof of Admission: Offer Letter or Admission Letter from IIM Trichy
 - v) Statement of cost of study / Schedule of Expenses
 - vi) 2 passport –size photographs
 - vii) If any previous loans from other Banks/Lenders, then Loan Account statement for the last 1 year
 - viii) Affidavit (Rs.100/- stamp paper & notarized) (Original)
 - ix) Assets and Liabilities statement

PARENT:

- Proof of Identity (Any one): PAN/Passport/Driver's License/Voter ID Card
- Proof of Residence /Address (Any One): Copy of Passport/Driving License/Aadhaar Card

Govt of India Subsidy:

- Income certificate from Tahsildar as per format attached, if annual family income below Rs.4.50 lakhs.
