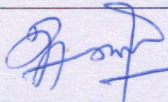

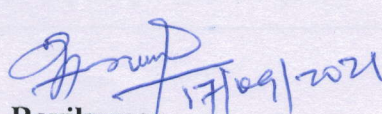

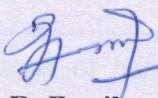

Page No. 9 Point No. h	The Vendor should be able to retrieve the exam question papers, answer scripts, video footages in a time-bound manner from the archive, as and when demanded by IIM Tiruchirappalli. These requests are to be entertained for at least three years since the date of administration of the exam.	<p><u>Option-I</u> If the bidder is willing to preserve the documents for 3 years from the date of examinations, IIM Trichy should be provided access to the question papers, answer scripts, video footages (including Video Recording, Face Recording and Screen recording of each candidate) for a minimum period of 3 (three) years.</p> <p>(or)</p> <p><u>Option-II</u> The Service Provider should provide the facility to IIM Trichy to download and store the question papers, answer scripts, video footages and all the proctoring related files (including Video Recording, Face Recording and Screen recording of each students) <i>in the readable & commonly used format without any additional software support</i> (i.e. the video file should be played in the VLC/Windows Media Player, pdf file should be readable in adobe reader and MS word file should be readable in MS Office 2010 & later versions) to IIM Trichy <i>within 3 months</i> from the date of completion of the exams. There should be options to download the files both student wise (individual download) as well as exam wise (bulk download). When we download the content in bulk (exam wise), the details of each student should be segregated in separate folders.</p> <p>The Service Provider should mandatorily provide service by either one of the above option but it would not be considered in evaluation by way of additional cost.</p>

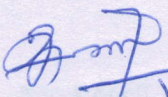

Page No: 30 Annexure 1A - Technical User Specifications Compliance Sheet, point #8.	My company has the willingness and ability to provide additional manpower for human proctoring (on a chargeable basis at additional cost) as and when requested by IIM Tiruchirappalli. Can we assume that we should be ready to provide the proctoring service at an additional cost which is not included in the tender value and hence when we submit Price Bid we should only be mentioning the cost of the proctoring examination platform with all mentioned features excluding the cost of providing human proctors?	<i>The bidders need to quote the price only for AI proctoring and should not include the price for human proctoring service in BoQ (Price Bid) of this tender.</i> However, the bidder should be ready to provide the manpower for human proctoring service at an additional cost, as and when required by IIM Trichy. The cost will be decided between the successful bidder and IIMT at the relevant point of time.
	Whether third party AI proctoring will be allowed to add additional software's along with proctoring platform?	No. IIM Trichy requires Complete AI Remote Proctoring Software package to conduct the online exams.
	We have worked with various IIMs and Public universities in past but not restricted to remote proctoring services but with larger transformation like ERP transformation.	
	Request if we can get exempted from this clause requesting for the remote proctoring services work orders and given a chance to showcase our propositions in the remote proctoring. We will share the work orders with respect to the ERP transformations in the IIMs/ IITs and Public universities.	Not accepted. The bidders should meet the eligibility conditions as mentioned in the tender document.
