- 4. The brand and specifications mentioned in the tender should only be delivered.
- 5. **Delivery:** within 10 days from the date of receipt of the Purchase Order. If the agency/firm fails to supply the items within the stipulated period, the Purchase Order will be canceled.
- 6. Warranty: One-year Warranty should be provided for the items.
- 7. The Bidder (s) should be registered with the Goods and Services Tax council for the purpose of Goods & Service Tax (GST). A copy of the GST registration certificate has to be submitted with the tender document.
