

Notice Inviting Tender for Supply of Floor Mount Movable Trolley Stand to IIM Tiruchirappalli





3. The bidder(s) should be registered with the Goods and Services Tax council for the purpose of Goods & Service Tax (GST). A copy of the GST registration certificate has to be submitted with the tender document. A copy of GST Registration Certificate, PAN and Bank account details should be submitted along with the Bid. The names appearing on all these documents and tender document should be same or linked.
4. **Additional Quantity Clause:**
IIM Trichy shall exercise an option to procure an additional Quantity of the items in addition to the quantity initially mentioned in the tender in accordance with the same rate, terms & conditions of the tender. It will be entirely at the discretion of the Buyer (IIM Trichy) to exercise this option or not.
5. **Repeat Order Clause:**
IIM Trichy shall place the Repeat Order for the same quantity of the items or less as per the rate quoted by the successful Bidder (L1) within six months from the date of supply/successful completion of the work and also with the same terms & conditions of the tender. In extraordinary circumstances, Repeat Order shall be placed within 1(one) year. It would be entirely at the discretion of the buyer (IIM Trichy) to place the repeat order or not.
