

Based on the discussion in the pre-bid meeting, the revised Technical Specifications along with dimensions are placed as Annexure-I & II
Page No 13, of the Tender Point 4 a. under Delivery Schedule	Delivery Schedule : Two weeks timelines for showing the Sample and 45 days timeline for the complete delivery of the Double-decker Cots.	The existing 30 days timeline for the delivery of the double-decker cots, as per the terms of the Tender, should be maintained due to the urgency of the item.
Page No 22 of the Tender Annexure-III, Technical Specifications	Whether the Ladder in the Cot needs to be welded or to be fixed with nuts and bolts?	The Ladder should be fixed with nuts and bolts with a suitable washer to make the fitting firm.


