Prof. Dharni Munusamy

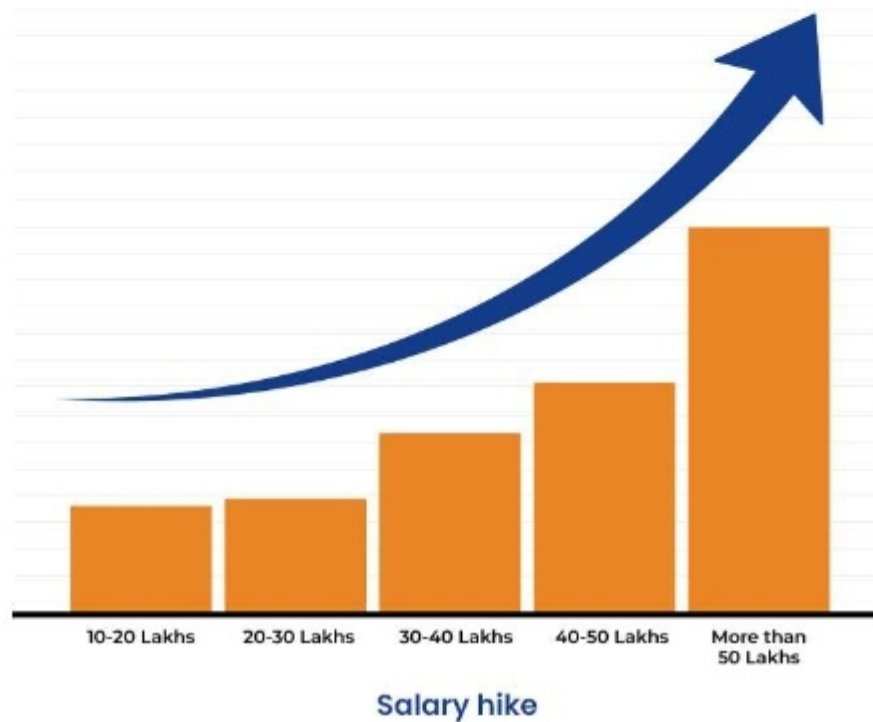

Programme Overview

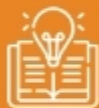

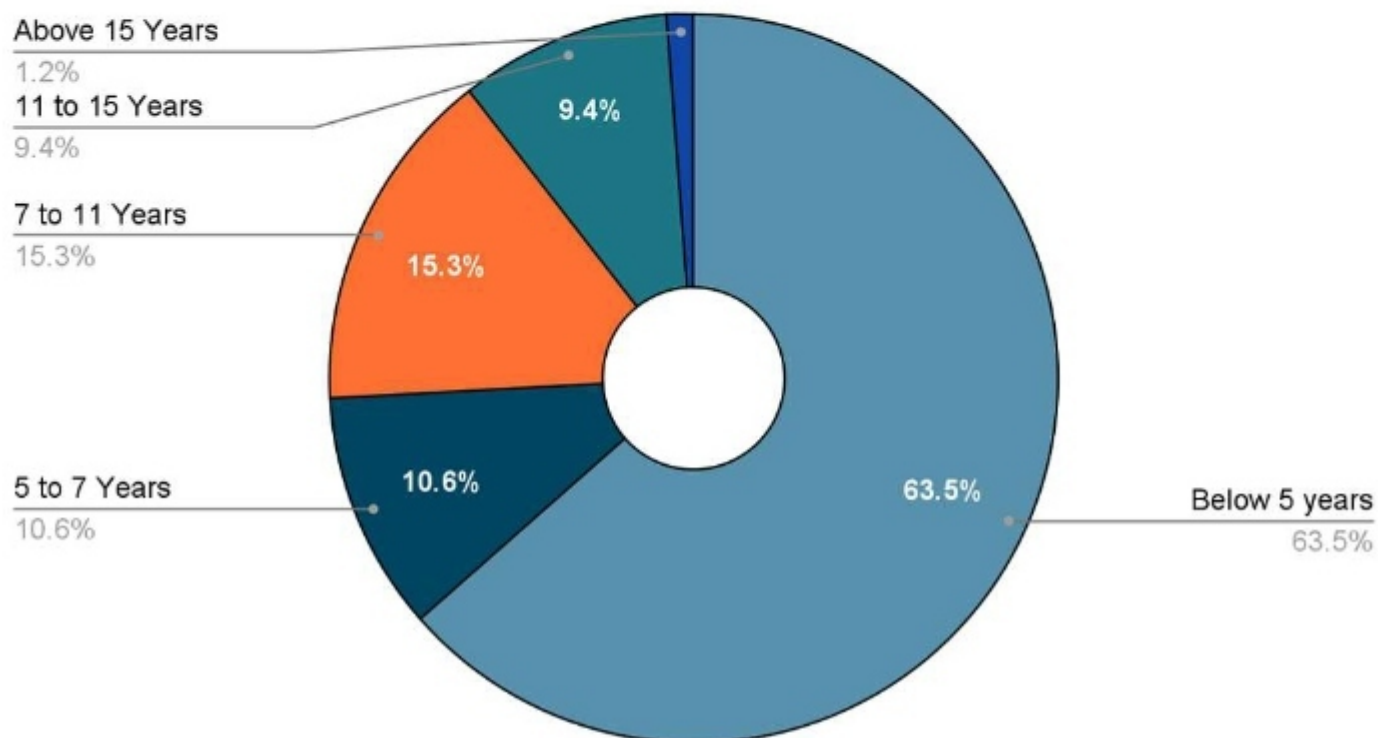

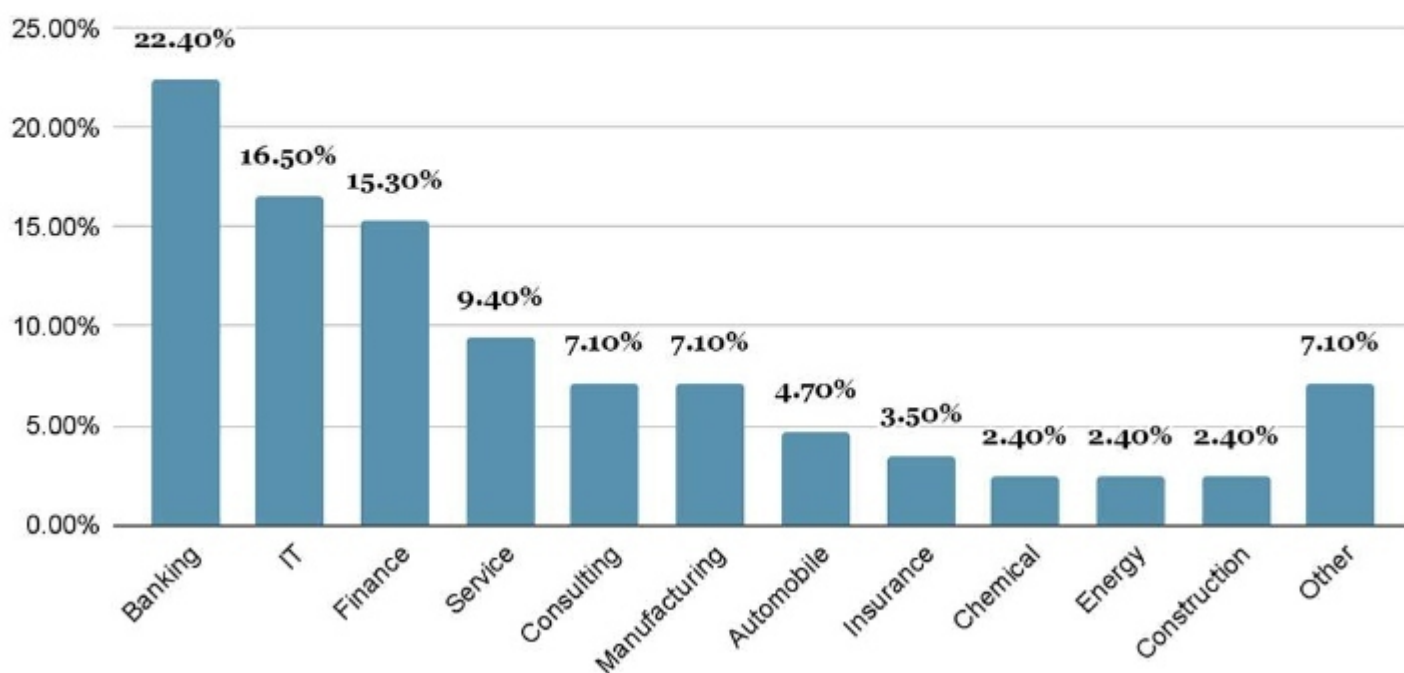
