A copy of the GST Registration Certificate, PAN and Bank account details should be submitted along with the Bid. The names appearing on all these documents and the tender document should be the same or linked.

#### 4. Delivery Schedule:

- a. The vendor should provide the DG's before the date of requirement (i.e. August 14, 2023) this same date trial checkup should be done, and the date of requirement would be August 15, 2023.
- a. In case the firm fails to complete work within the specified period, the Work/Purchase Order as a whole will be terminated. Applicable penalties would be levied to the supplier/vendor. The decision of the competent authority in the matter of penalties would be final and binding.

# 5. Scope of work:

- a) Provisioning of 01 No 500 KVA 415 V 3 Ph 50 Hz and 1 No of 15 KVA 415 V 3 Ph 50 Hz. The generator should be provided with Sound and Weatherproof, with proper temporary earthing.
- b) Contractor should ensure stabilized electrical power supply is provided to the distribution panel.
- c) The distribution panel should have operational and calibrated Voltmeters, Ammeters, Frequency meters and KW meter for the generator and provision of protection against over current, under voltage/overvoltage
- d) Distribution board and cable from Generator to distribution board to be provided by the contractor.
- e) All consumables other than the fuel is the responsibility of the contractor. Fuel is the scope of the Institute.
- f) The Generator should be of less than three years old.
- g) The generator should have trials reports from certifying agency
- h) The generators should have weatherproof acoustic enclosures and well-maintained control panel with all parameters indicated for monitoring performance
- i) The contractor will be liable to change the generator in case it fails to achieve rated output during the running period, owing to a major defect or degradation in performance.
- j) Necessary firefighting arrangements for the generators to be provided.
- k) The requirement of the crane/lifting tools etc during installation/shifting/closure of the contract to be catered by the contractor and no extra charge will be paid by IIMT.
- l) If the DG (Diesel Generator) fails during the running period, the amount will be deducted in accordance with IIMT norms.
- m) The contractor is required to assign one operator during the running period of the DG (Diesel Generator).

#### 6. Payment Terms:

- a. No advance payment will be made in any case.
- b. Payment will be released within 25 days' subject to submission of Invoice/Bill.
- c. The payment will be released only for the DG's utilized days.
- d. TDS and any other Government levies applicable on bills as per Government instructions/ notifications issued from time to time shall be applicable and deducted from Service Provider's bills.

#### 7. Penalty Clause:

Deficiency/delay in work/services will be construed as lapses on the part of the vendor. Such lapses due to Vendor will be viewed seriously and penalties will be imposed on the Vendor in case of any delay in completing the required work as covered by this Tender within the stipulated date and timings. IIM Tiruchirappalli reserves the right to impose the penalty and the quantum of the penalty will be decided in individual cases and the decision of the competent authority at IIM Tiruchirappalli shall be final and binding.

8. The quote shall remain valid and open for acceptance for a period of 90 days from the date of opening of the bid.

- 10. The work will be carried out as per instructions of the Estate Office at the site and nothing extra will be paid on this account.
- 11. The contractor shall bear all incidental charges for cartage, storage, and safe custody of the materials.
- 12. Site Visit: The bidders are requested to make the site visit by the vendor before quoting the rate to assess the nature of the work and better understand the requirement.
- 13. Bidder should take into account the corrigendum/Addendum published in the IIM Trichy website in the tender page from time to time before submitting the bids.

- 15. The vendor should quote the rate for all the items, failing which the quotation will not be considered for further evaluation.
- 16. The bidder should submit the tender/quotation duly signed and stamped on all the pages.
- 17. IIMT reserves the right to change/extend/modify/amend or delete any of the conditions, clause or items stated therein any or all provisions of this tender document. Such revisions / amended/corrigendum will be made available on the website of the IIMT Tender portal.
- 18. IIMT also reserves the right to withhold or withdraw the process at any stage with intimation to all the bidders who have submitted the quotation/tender.
- 19. IIMT will not be responsible for any loss in transit or postal delay.
- 20. Tax will be deducted as per the rule in force.
- 21. **Arbitration:** In case of any unreconciled disputes between the parties IIM Tiruchirappalli and the agency/firm to whom the contract had been awarded, arising out of any of the terms of the Contract Agreement, the dispute shall be referred to a single Arbitrator mutually agreed, as per Arbitration and Reconciliation Act 1996, in Tiruchirappalli jurisdiction. The decision of the Arbitrator shall be final and binding on both parties.
- 22. **Jurisdiction:** All disputes arising out of this contract shall be subjected to the Courts at Tiruchirappalli.

### 23. Force Majeure:

- a) Should any force majeure circumstances arise, each of the contracting parties be excused for the non-fulfillment or for the delayed fulfillment of any of its contractual obligations, if the affected party within 15 days of its occurrence informs in a written form the other party.
- b) Force Majeure shall mean fire, flood, natural disaster, or other acts such as war, turmoil, sabotage, explosions, epidemics, quarantine restriction, strikes, and lockouts i.e. beyond the control of either party.
