Instructions for Online Bid Submission

The bidders are required to submit soft copies of their bid electronically on the e-Wizard Portal using valid Digital Signature Certificates. Below mentioned instructions are meant to guide the bidders for registration on the e-Wizard Portal, prepare their bids in accordance with the requirements and submit their bids online on the e-Wizard Portal. For more information, bidders may visit the Portal (https://mhrd.euniwizarde.com/)

1. Registration Process on Online Portal

- a. Bidders to enroll on the e-Procurement module of the portal https://mhrd.euniwizarde.com/ by clicking on the link "Bidder Enrolment".
- b. The bidders need to choose a unique username and assign a password for their accounts.
- c. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. This would be used for any communication from the e-Wizard Portal.
- d. Bidders to register upon enrolment, with their valid Digital Signature Certificate (Class III Certificates with signing and Encryption key) issued by any Certifying Authority recognized by CCA India with their profile.
- e. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible for ensuring that they do not lend their DSCs to others which may lead to misuse.
- f. Bidder then logs in to the site through the secured log-in by entering their user ID/password and the password of the DSC / e-Token

2. Tender Documents Search

1. OVERVIEW

IIM TIRUCHIRAPPALLI invites e-Tender for Supply, Installation, Testing and Commissioning of Wearable Microphones and Analog Audio Mixers to IIM Tiruchirappalli.

2. BASIC ELIGIBILITY CONDITIONS FOR THE BIDDERS

- a. The bidder(s) should be registered with the Goods and Services Tax council for the purpose of Goods & Service Tax (GST). A copy of the GST Registration Certificate, PAN and Bank account details should be submitted along with the tender document. The names appearing on all these documents and the tender document should be the same or linked.
- b. The Bidder should give a self-declaration certificate for acceptance of all terms & conditions of tender documents. A duly completed certificate to this effect is to be submitted as per Annexure-IV.
- c. The bidders should not be blacklisted by any department of the Government of India or any State Government and Private organization in the past. There should not be any criminal case registered against the bidding firm or its owners/partners anywhere in India. An undertaking to this effect in the Company letterhead duly signed by the owner/partner or both to be enclosed, as per Annexure-V..

3. BID PREPARATION

- a. Bidders should take into account any corrigendum published on the tender document before submitting their bids.

4. PROCEDURE FOR SUBMISSION OF TENDER

- a. Bidder to log into the site well in advance for bid submission so that he/she uploads the bid in time, i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- b. The tender document should be downloaded from the IIM Tiruchirappalli website https://www.iimtrichy.ac.in/tender-published and e-Wizard Portal https://mhrd.euniwizarde.com/
- c. The bidder(s) shall not make any changes or amendments to the tender document as published on the IIM Tiruchirappalli website and MoE's e-Wizard Portal.
- d. All the pages of the tender document being submitted must be duly (Digitally) signed as per the procedures and requirements stipulated herein.
- e. The tender document should be filled in legible handwriting/printing/typing without any ambiguity.
- f. If any correction is necessary on the information provided by the bidder, the same should be made after scoring out the old entry. In any case, there should not be any overwriting. All the corrections should be attested with the full signature of the bidder with the date.
- g. Bidder should take into account the corrigendum/Addendum published from time to time before submitting the bids.
- h. The bidders are cautioned that furnishing of incomplete/ambiguous information, suppression of facts and any alteration of the prescribed tender format will entail outright rejection of the bid application.

5. EARNEST MONEY DEPOSIT

- a. The bidder(s) should remit an Earnest Money Deposit (EMD) of Rs. 4, 200/- (Rupees Four Thousand Two Hundred only) at MoE's e-Wizard Portal. A copy of the payment transaction receipt has to be attached with the e-Tender application form, without which the tender won't be considered for the bidding process.
- b. The EMD of the successful bidder will be returned after making the final payment.
- c. The EMD of the unsuccessful bidders will be released after the finalization of the tender. No interest is payable on the Earnest Money Deposit (EMD).
- d. Micro and Small Enterprises (MSEs) firms as defined in the MSE Procurement Policy issued by the Department of Micro, Small and Medium Enterprises (MSME) or the firms registered with the Central Purchase Organization or the concerned Ministry or Department or Startups as recognized by Department of Industrial Policy & Promotion (DIPP) for all these items only,

e. The bidders who seek exemption from EMD as per the clause above, if they withdraw or modify their bids during the period of validity, or if they are awarded the contract, and they fail to sign the contract or to submit performance security before the deadline defined in the bid document, they will be suspended for the period of three years or as decided by the competent authority from being eligible to submit bids for contracts with the entity that invited the bids.

GENERAL TERMS & CONDITIONS

a) The successful bidder should provide a letter for the Warranty period of **One year** for the *Supply*, *Installation*, *Testing and Commissioning of Wearable Microphone and Analog Audio Mixer to IIM Tiruchirappalli*.

b) DELIVERY SCHEDULE

- i. The successful bidder should complete the *Supply, Installation, Testing and Commissioning* of *Wearable Microphone and Analog Audio Mixer to IIM Tiruchirappalli* within 15 days from receipt of the Purchase Order.
- ii. In case the firm fails to supply, Commissioning/install the required items within the specified period, the Purchase Order as a whole may be terminated. Applicable penalties would be levied to the supplier/vendor. The decision of the competent authority in the matter of penalties would be final and binding.

c) PAYMENT TERMS

- i. No advance payment will be made in any case.
- ii. Payment will be released after successful commissioning/installation of all the items/supply of all the items within 25 days' subject to submission of Invoice/Bill with all relevant documents like warranty certificate, etc.
- iii. TDS and any other Government levies applicable on bills as per Government instructions/ notifications issued from time to time shall be applicable and deducted from Supplier/Vendor/Service Provider's bills.

d) WARRANTY OF QUALITY

- i. The item supplied should carry the warranty as per the requirement mentioned in Technical Specification Section (Annexure-III). The successful bidder should provide a letter for the Warranty period of Three years for the Supply, Installation, Testing and Commissioning of Revolabs Microphone and Analog Audio Mixer to IIM Tiruchirappalli.
- ii. The defects, if any, during the guarantee/warranty period are to be rectified free of charge by arranging free replacement wherever necessary. IIM Tiruchirappalli officials would claim the warranty either directly with the OEM or through the successful bidder/supplier.

e) PENALTY CLAUSE

Deficiency/delay in Supply/Quality will be construed as lapses on the part of the vendor. In case the Vendor fails to supply any items within a specified delivery period, the same items will be obtained from the open market and the difference in cost, if any, will be recovered from the EMD or from the pending bill(s) of the defaulting firm or the Vendor if the recoverable amount exceeds the EMD and if there are no pending bills due to be paid to the respective Vendor.

f) Additional Quantity Clause:

IIM Tiruchirppalli shall exercise an option to procure an additional Quantity of the items in addition to the quantity initially mentioned in the tender in accordance with the same rate, terms & conditions of the tender. It will be entirely at the discretion of the Buyer (IIMT) to exercise this option or not.

g) Repeat Order Clause:

IIM Tiruchirppalli shall place the repeat order for the same quantity of the items or less as per the rate quoted by the successful Bidder (L1) within six months from the date of supply/ successful commissioning/installation of the work with the same terms & conditions of the tender. In extraordinary circumstances, a repeat order shall be placed within 1(one) year. It would be entirely at the discretion of the buyer (IIMT) to place the repeat order or not.

h) CONDITIONAL BIDS

Conditional bids or Bids based on the process / basic schemes other than mentioned and / or not conforming to the technical specifications / requirements of the Bidding documents will not be considered.

i) BIDS CRITERIA

- i. The bidder should quote the rate for all the items mentioned in the Price Bid (BoQ), otherwise, the price bid will not be considered for evaluation.
- ii. The Bidder should quote the rate for the brands and specification mentioned in price bid, else the bid will be rejected.
- iii. The rates quoted by the tenderer should be inclusive of all charges (Delivery to IIM Tiruchirapalli), Supply, Installation, Testing, Commissioning, Packing, Loading and unloading, etc., but *except GST* and must hold good till the completion of the supply/work and shall not be subjected to any escalation. No claim on this account whatsoever shall be entertained at any stage, including the extended period, if any.
- iv. Price Bid i.e. BoQ given with the tender to be submitted after filling all relevant information and it should be as per the specifications *mentioned in the price Bid* (*Annexure-II*) and as per the format available with the tender, failing which the offer will be rejected (renaming or changing the format of BoQ) will not be acceptable. The Bidder should quote the price inclusive of all charges but *exclusive of GST*.

- v. The quantities mentioned in Price Bid are tentative and shall be increased or decreased depending upon the requirements of the Institute.
- vi. *Price Bid* (BoQ) given in tender to be submitted after filling in all relevant information. The priced BoQ should be submitted strictly as per the Price Bid (BoQ) <u>Annexure-II</u>, failing which the offer will be rejected.
- vii. Arithmetical errors, if any, shall be rectified on the following basis. If there is a discrepancy between the unit price and total price, then the unit price shall prevail, and the total price shall be corrected by the Institute. If the Bidder does not accept the correction of the errors, the bid shall be rejected. All Rates, Prices, Amounts and Sums quoted by the bidder shall be in Indian currency only. The language used throughout shall be English.

j) VALIDITY OF BIDS AND RATES

- i. All the quoted rates would be valid until the completion of the contract. No escalation of price whatsoever would be allowed during the currency of the contract, including an extended period if any.
- ii. The quote shall remain valid and open for acceptance for a period of 90 days from the date of opening of the bid.
- k) Canvassing in connection with the tenders is strictly prohibited, and tenders submitted by the tenderers who resort to canvassing will be liable to rejection. Any bribe, commission or advantage offered or promised by or on behalf of the tenderer to any officer or staff of IIM Tiruchirppalli shall block his/ her tender from being considered. Canvassing on the part or on behalf of the tenderer will also make his tender liable to rejection.
- 1) Authority of the person signing the document: A person signing the tender application or any documents forming part of the contract on behalf of another shall be deemed to warranty that he/she has authority to bind such other and if, on enquiry, it appears that the person, so signing had no authority to do so, the IIM Tiruchirppalli may without prejudice to other civil and criminal remedies cancel the contract and held the signatory liable for all cost and damages.
- m) In respect of the supply to IIM Tiruchirppalli, the vendor shall be liable for depositing all taxes, levies, cess, etc., to the concerned tax collection authorities from time to time as per existing rules and regulations on the matter.
- n) <u>Arbitration:</u> In case of any unreconciled disputes between the parties IIM Tiruchirppalli and the agency/firm to whom the contract had been awarded, arising out of any of the terms of the Tender document, the dispute shall be referred to a single Arbitrator mutually agreed, as per Arbitration and Reconciliation Act 1996, in Tiruchirapalli jurisdiction. The decision of the Arbitrator shall be final and binding on both parties. The language of the arbitration shall be English. The Place and seat of arbitration shall be in Tiruchirppalli.
